### ORDER:

In the G.O. first read above, the Government have notified "The District Mineral Foundation Rules, 2017 to establish a Trust in each Districts of the State and collect District Mineral Foundation Fund from the lessees of major and minor minerals as per the rates specified in this rules with effect from 12.01.2015.

2. In the letter third read above, the Commissioner of Geology and Mining has requested for amendments. Accordingly, the following Notification will be published in the Tamil Nadu Government Gazette:-

### NOTIFICATION

In exercise of the powers conferred by sub-section (4) of section 15 of the Mines and Minerals (Development and Regulation) Act, 1957 (Central Act 67 of 1957), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu District Mineral Foundation Rules, 2017.

2. The amendments hereby made shall be deemed to have come into force on 19<sup>th</sup> May 2017.

**AMENDMENT**

In the said Rules,  
(1) in rule 8 -

- (i) for the expression "before the 12<sup>th</sup> January 2015", the expression "after the 12<sup>th</sup> January 2015" shall be substituted;
- (ii) for the expression "after the 12<sup>th</sup> January 2015" the expression "before the 12<sup>th</sup> January 2015" shall be substituted;

(2) in Appendix, for the para 13 the following para shall be substituted, namely:-

**"13. OPERATION OF THE TRUST FUND.-** The Trust Fund shall be deposited in any Nationalized Bank only in the name of the Trust and all accounts shall be operated under the joint signatures of the Chairperson and any one other member of the Managing Committee nominated by the Chairperson. The Trust shall maintain the books of accounts of the Fund".
